**TO ST. LOUIS PARISH ACTIVITY CENTER FROM:**

***New Orleans area:*** Take Interstate 10 to Baton Rouge, and exit at Siegen Lane going East. Siegen Lane becomes Sherwood Forest Blvd. at Airline Hwy. (US 61). Proceed on Sherwood Forest Blvd. through several major intersections (Coursey, I-12, Old Hammond Highway, Florida Blvd. [US 190]). Sherwood Forest Blvd. becomes Sherwood Forest Dr. at Florida Blvd. Continue North after crossing Florida Blvd. approximately 3/4 mile and the facility is located on the left, between the Church and the school. Limited parking is available in front of the facility and the nearby school with additional parking near the church.

***East (Hammond, etc.):*** Take Interstate 12 to Baton Rouge. Take Exit 4 Sherwood Forest Blvd. and turn right. Proceed north on Sherwood Forest Blvd. The 5<sup>th</sup> traffic light is Florida Blvd (US 190). Sherwood Forest Blvd. becomes Sherwood Forest Dr. at Florida Blvd. Continue North. The facility is located approximately 3/4 mile past this intersection on the left, between the Church and the school. Limited parking is available in front of the facility and the nearby school with additional parking near the church.

If coming in on US 190 (Florida Blvd.) turn right at the Sherwood Forest Dr. intersection [Sherwood Forest Blvd. becomes Sherwood Forest Dr. at Florida Blvd.] and proceed north approximately 3/4 mile. The facility is located on the left.

***West (Lafayette, etc.) and North via the Interstate:*** Take Interstate 10 to Baton Rouge. At I-10/I-12 veer left to Interstate 12 going East (To Hammond). Take Exit 4 for Sherwood Forest Blvd and turn left (North). The 5<sup>th</sup> traffic light is Florida Blvd (US 190). Sherwood Forest Blvd. becomes Sherwood Forest Dr. at Florida Blvd. Continue North. The facility is located approximately 3/4 mile past this intersection on the left, between the Church and the school. Limited parking is available in front of the facility and the nearby school with additional parking near the church.
